## **PRACTICE DIRECTION 4 OF 2021**

## Written Submissions to Magistrates Court, Perth

1. Practice Direction 2 of 2012 is revoked.

Criminal, Restraining Orders and Extraordinary Licence Applications

2. For matters in the Court's criminal jurisdiction and in the Court's civil jurisdiction where electronic lodgment of documents is not mandated, if a party is required to or wishes to make submissions or otherwise bring materials to the attention of a Magistrate prior to the hearing date at the Perth Magistrates Court, the attached face sheet should be completed and attached to the materials. The materials can be lodged in person, by mail, by fax or by email.

## Civil Matters (Electronic Lodgment)

- 3. For matters in the Court's civil jurisdiction where electronic lodgment of documents is mandated, if a party is required to or wishes to make submissions or otherwise bring materials to the attention of a Magistrate prior to the hearing date at the Perth Magistrates Court, the materials must be lodged in accordance with the requirements of ECMS. The materials must be lodged using ECMS unless an exemption applies. Where an exemption applies, the materials must be lodged in accordance with paragraph 2.
- 4. Compliance with this Practice Direction will facilitate the efficient delivery of the materials and assist with tracking.
